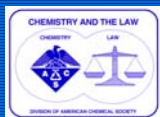

Dear Sir/Madame:

The organizing committee of Beijing International Pharmaceutical & Chemical Intellectual Property Forum is pleased to announce that the forum will be held on April 25-28, 2006, in Beijing, China. The forum will provide a platform for an open dialogue on Chinese and international practices in IP law, especially patent laws as applied in the pharmaceutical and chemical industries. It will also aim to create business and networking opportunities among participants. Because the IP Forum is to be privately run (a first in China for an IP conference), and the organizers, the China Intellectual Property Society (CIPS), the Chinese American Chemical Society (CACS), the Division of Chemistry and Law of American Chemical Society (ACS-CHAL), and the China International Economic and Trade Arbitration Commission (CIETAC) are all non-profit organizations, we cordially invite your organization to consider financial sponsorship for this forum.

As China is rapidly integrating with the world economy, the establishment of legal protection for intellectual property within China's borders and its adherence to internationally accepted IP practices overseas are becoming increasingly important for China's economic development. The rest of the world should stand to benefit from a China with high standards of IP practices as well. Many recent press reports have cited concerns about current sub-standard IP practices in China as major impediments to conducting high-IP content businesses in China. This IP Forum will provide a venue to exchange views and discuss best approach forward with those in advisory capacity for Chinese IP decision makers.

There is also a growing sense of urgency within China, especially since its joining of the WTO, to adapt to internationally acceptable IP practices. Along with this urgency arise business opportunities for western law firms and industrial companies intending to establish IP related business ties with China.

### **Sponsorship Details**

#### Bronze Sponsorship Level: \$3,000 - 9,900
